1. Public comments.
2. Approve minutes.
3. Financial and bookkeeping matters, including payment of the bills, review of investments, and amend budget, as appropriate.
4. Budget for fiscal year end May 31, 2025.
5. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
6. Engineering matters, including preparation of plans and specifications, approval of plans and specifications, advertisement for bids, bid review, contract award, Pay Estimates and Change Orders, acceptance of projects, and direct engineer to notify insurance company of new facility, if appropriate.
7. Unlimited Tax Bond, Series 2024, including:
  - a. authorize engineer to prepare bond application;
  - b. engage auditor to prepare developer reimbursement report; and
  - c. adopt Resolution Authorizing Application to the Texas Commission on Environmental Quality for Approval of Project and Bonds.
8. Authorize acceptance and/or conveyance of deeds, easements, and consents to encroachment, and abandonment of easements.
9. Discuss future park projects, utilization of open space and recreational matters, review proposals and authorize appropriate action.
10. Report on maintenance of District facilities, including lake improvements, review proposals, and authorize appropriate action.
11. Discuss security matters and Flock Security cameras proposal and authorize appropriate action.
12. District website matters, including discuss changes and updates to website.
13. Report regarding development in the District, including financing agreements and assignments of financing agreements.
